1. Call to order — roll call

2. Old Business:

- **a. Treasurer's Report** (Sue): See last page. Our Membership Drive will start in November for renewals and new members.
- **b. By-laws Update** Barbara Fleming, Dori Frankel and Donna Snyder will meet and work on these hopefully for a review by November's board meeting.

c. Updates on continuing issues

- International Wildlife Museum: The property sold at auction for \$987,500. Dori reported that a report from Pima County recorder's office showed no new owner of record yet. We will continue to monitor.
- **d. 4202 Anklam**: Barb reported in advance that the county has issued a citation regarding the egregious lighting violations, and she is following up on this continuing saga.
- **e. Las Lomas property on Speedway:** Now known as Tucson Mountain Guest Ranch. Three of the buildings are now rentable Air B+Bs. Will continue to follow up.
- f. Boards and Commissions (Tony via email): Nothing to report at this time.
- **g. New board members** Donna stated she has been working on recruiting new board members, and has had some positive responses, but no actual acceptances to run for a position as of yet. She asked that other board members also pursue this avenue.

3. New Business:

- **a. Fall Cleanup and Pot Luck October 19, 2024**. For the pickup we meet at 8 am at the Painted Hills Church Parking lot. Barb Fleming facilitates. **Our Fall Membership Meeting and Pot Luck** will meet at 10 am at the home of Donna and Bob Snyder. The PC Sheriff's Department will be speaking on scams and fraud detection. Colin Waite will be speaking about the Cooper Center. Donna will send out an email to the general membership reminding them of these events next week.
- **b. Twin Hills Estates on Mountainside** Barb reported in advance that the owner of property on the south side of Anklam, adjacent to Twin Hills Estates on Mountainside, was issued a citation on 9/5/2024 as he neglected to apply and pay for a grading permit for a short driveway extension. Barb has been working with the neighbors on issues with this developer for a while.

- **c. KBHomes:** The Proposed high density housing development at St Mary's and Anklam. GPANA was approached by an advocate for mitigating the plan so as to lessen the effect on Tumamoc Hill. After discussion by the board members it was decided that this is well outside our area of concern, and at this point, with a full plate of issues, it is not something that we can take on.
- **d. Columbus Park Name Change to Danny Lopez Park**: A proposal was submitted to Tucson City Parks and Recreation by community leaders, Lopez family members, and the Tucson Native Youth Council. As an organization, it was voted that the board would not get officially involved, but make our members aware so that they can weigh in if they so choose.
- **c. Carrie Stern**, guest and potential board member, reported that the area of Via Roma where she resides has two Air B&B's that have caused considerable distress to the neighbors in that area. She and others in the area are following up with complaints to the property owners and Air B&B offices with not much success. Carrie also informed us that her partner, Gary Geiler, is very knowledgeable with venomous snakes, and able to relocate same if requested.

The meeting was adjourned at about 11:45 AM.
